

<i>Discipline 17/2012</i>	Failing to comply with an order of the BDT dated 27 July 2017 that you should be advised as to conduct by the Chairman of the Bar Association, or his nominee.
<i>Discipline 15/2015</i>	Failing to respond promptly to any request from the Bar Council or the Standing Committee on Discipline for comments or information on the disciplinary matter.
<i>Discipline 01/2017</i>	Failing to respond promptly to any request from the Bar Council or the Standing Committee on Discipline for comments or information on the disciplinary matter.
<i>Discipline 03/2017</i>	Failing to respond promptly to any request from the Bar Council or the Standing Committee on Discipline for comments or information on the disciplinary matter.
<i>Discipline 06/2017</i>	Failing to inform a Torture Claim Appeal Board (“ <b>the Board</b> ”) of the fact that you only had limited instructions to act for the claimant when appearing for him during the Board’s hearings on 13 and 16 January 2017, and being discourteous to the Board in the course of the proceedings before it.
